----- 3. - Hazards Identification -----

Emergency Overview: Milky, colloid mixture. Slight acidic odor. Low hazard for usual industrial or commercial handling.

Effects of Overexposure - Eye Contact: Eye contact may cause slight irritation.

Effects of Overexposure - Skin Contact: No hazard expected in normal industrial use.

Effects of Overexposure - Inhalation: No inhalation hazard expected during normal workplace use.

Effects of Overexposure - Ingestion: Harmful if swallowed. Ingestion is not an expected route of entry in industrial or commercial uses.

Effects of Overexposure - Chronic Hazards: None expected under normal working conditions.

----- **4. - First Aid Measures** -----

Skin: Flush contaminated skin with large amounts of water while removing contaminated clothing. Wash affected skin areas with soap and water. Get medical attention if symptoms occur.

Eyes: Flush eyes immediately with large amount of water for at least 15 minutes holding eyelids open while flushing. Get prompt medical attention.

Inhalation: This material is not likely to be hazardous by inhalation. However, if exposed to excessive levels of vapor or mist, remove to fresh air, give oxygen if breathing is difficult, and get immediate medical attention.

Ingestion: If swallowed, do not induce vomiting. Give victim one or two glasses of water or milk. Call a physician or poison control center immediately for further instructions. Never give anything by mouth to an unconscious person.
